The qualification includes the company's range of high quality, dependable and durable MIFARE Classic PRELAM®, MIFARE DESFire PRELAM® and MIFARE-compatible Infineon SLE66R35 PRELAM® products.

In addition, SMARTRAC's MIFARE Classic ISO white cards, MIFARE DESFire ISO white cards and MIFARE-compatible Infineon SLE66R35 ISO white cards have been certified by AIT.

The AIT Austrian Institute of Technology, formerly known as arsenal research, is an independent cutting-edge research institute of European format which has now started qualifying RFID smart card inlays in addition to certifying complete RFID smart cards. The certification and qualification ensures compatibility with the MIFARE air interface and compliance with the related parts of the ISO/IEC 14443 standard.

AIT certification is a proof of quality, reliable functionality and compatibility. Customers benefit from increased flexibility and cost savings as they are now able to obtain certification of their finished smart cards based on SMARTRAC's qualified PRELAM® and certified white card products.
